

# STANDARDS COMMITTEE

## Purpose:

Maintain and enhance the professional practice of Alberta Land Surveyors.

## On an ongoing basis, the Committee shall:

1. Monitor standards and specifications for iron posts and marker posts.
2. Liaise with LTO regarding any changes concerning the LTO Procedures Manual.
3. Update the Manual of Standard Practice as required.

## For 2018-2019, the Committee shall (in order of priority):

1. Investigate what assurance the ALSA can provide to Land Titles that there are safeguards in place if a land surveyor attempts to alter a survey plan or document (*Council Motion 2017.12.023*)
2. Investigate making the means practitioners use to deal with linear activities that are in both private and Public Lands, typically PLAs/DPLs and EZE's consistent.
3. Based on the feedback from the questionnaire to members, monitor standards and specifications for iron posts and markers posts and make recommendations to Council. (*Member Engagement*)
4. Review the purpose statement, signature requirements and copyright statements in the real property report section of the Manual of Standard Practice and make recommendations to Council. (*Council Motion 2018.02.052*)
5. Provide clarification regarding their request for a subgroup of the committee to provide input on standards of practice and plan standards for hybrid cadastre plans. (*Council Motion 2018.03.021*)

## The Committee Chairman shall:

1. Review and approve all agendas and committee minutes.
2. Ensure that a vice-chairman is appointed (no later than the second meeting of the year).
3. Prepare and be responsible for the Committee's terms of reference – including its budget.
4. Prepare an annual report of the Committee's accomplishments and make recommendations for changes to the Committee's terms of reference. (January)

## The Committee shall consist of:

Council shall appoint, by motion, not less than ten committee members recruited from the general membership, which includes the Director of Surveys. The terms of appointment of all ALSA committee members will be two years. All Committee members are eligible to vote.
